## Eligibility

Entry is open to any amateur golfer between the ages of 10-17, as of the first day of the championship. Entries are subject to rejection at any time, including during the event. The reason for rejection may include unbecoming conduct.

## Rules

USGA rules will govern play. Local rules will be distributed at the starters table. Fort Mill Golf Club reserves the right to alter the conditions as stated, reduce the number of holes to be played, or make any other changes in conducting this tournament as they deem necessary. Use of tobacco products by competitors is strictly prohibited. Caddies are not permitted.

## Format

Boys 15-17	Blue Tees	36 Holes
Boys 13-14	White Tees	36 Holes
Boys 10-12	Red Tees	18 Holes

The champion is the low scorer of each age division. There will be a sudden death playoff for a first place winner in each age group. All other ties will be decided by a scorecard playoff.

## Prizes

Trophies are awarded to the Champion, Runner-up, and 2<sup>nd</sup> Runner-up in each age division.

## Entries

Each entrant must complete an official entry form. No entry will be accepted prior to the opening date. Entries will be accepted until 5 p.m. of the closing date. Fort Mill Golf Club is not responsible for errors or delays by any mail courier. Confirmation of acceptance will be sent to players after closing date. Entries received before the opening date will be returned. **Entries must be returned to Fort Mill Golf Club, PO Box 336, Fort Mill, SC 29716.** Fax, telephone, late or incomplete entries will not be accepted. The entry fee must be paid by each player and must accompany this form. Please make checks payable to Fort Mill Golf Club. **Refunds will not be issued after June 20, 2010.**
