



# 2010 Tarheel Youth Golf Association Par Three Shootout Official Entry Form

*Entry Fee: \$20 per player*

*All competitors will play 18 holes, with the 10 qualifiers and the defending champion playing a nine-hole shootout to determine the winner.*



**Eligibility:**

- Must be 8 - 18 years of age as of July 14, 2010 and have not started college.
- TYGA Members Only (Eligible players may fill out the entry information to gain free membership.)
- **One check per entry.** Enclose entry fee payable to TYGA, PO Box 319, West End, NC 27376.

Each player must complete an official entry form. Entries received prior to the open date will be returned. Entries will be accepted until 5 p.m. of the close date or until the field is filled (44 players). Entries must be returned to the Tarheel Youth Golf Association (see above address). Fax, e-mail, telephone, late, or incomplete entries will not be accepted. **Confirmation of acceptance will only be sent via e-mail and posted to [www.tyga.org](http://www.tyga.org).** No refunds will be given after entries close. TYGA is not responsible for any errors or delays with any mail courier.

**The field will be limited to the first 44 entries received.** Entries are subject to rejection at any time, including during the tournament, by the Carolinas Golf Association, the Tarheel Youth Golf Association, or the host club. The reason may include unbecoming conduct. **Players failing to show without either notifying the CGA office or the host site prior to the event may be subject to rejection from future events.**

Lunch is provided by TYGA and the host club. Each competitor must walk and carry his/her own bag (pull carts allowed if club agrees) during the stipulated round, unless the player employs a caddie. In that case, the caddie must be 18 or younger and must walk. Tee time assignments will be made available at the host site two days prior to the event and at [www.tyga.org](http://www.tyga.org).

**Practice rounds are not included in the tournament entry fee.** Tobacco products are prohibited. USGA Rules of Golf govern all competitions. Local rules will be distributed at each site and are located at [www.tyga.org](http://www.tyga.org). For more information call the Carolinas Golf Association: (910) 673-1000.

Age divisions will be as follows: Boys 16-18, Boys 14-15, Boys 12-13, Girls 16-18, Girls 14-15, and Girls 12-13 and 11 and under. TYGA reserves the right to alter the above divisions due to field size. The defending champion (Kendrick Vinar) and one player from each age division will qualify for the shootout. The next lowest three scorers not otherwise qualifying will also be entered into the shootout for a total of 11. Ties for age division winners or spots in the shootout will be broken with a closest to the hole contest on hole #1 as soon as the need is identified. Players are responsible for making themselves available. The shootout will consist of all players playing the first hole with the two high scorers eliminated. Ties for elimination will be broken with pre-determined closest to the hole shots from around the putting green. Starting with the second hole, the shootout will eliminate one player per hole until there is one player left, who will be declared the champion after play of the ninth hole. Trophies will be awarded to all players who qualify for the shootout.
